For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the Bank's Disbursement Guidelines and procedures for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit.

- 2. The Africa CDC now invites sealed Bids from eligible Bidders for Supply, delivery, installation and commissioning of IT equipment, accessories and other various equipment for the establishment Public Health Emergency Operations Centers (PHEOCs) in 23 Africa Union Members States.
