The Africa Union the Recipient has received financing from the African Development Bank hereinafter called the Bank toward the cost of the Africa CDC Covid-19 Response Project, and intends to apply part of the proceeds toward payments under the contract for the Supply, delivery, installation and commissioning of various equipment, tools and items for the Douala Continental Logistics Base renovated warehouses. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the Bank's Disbursement Guidelines and procedures for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit.
2. The Africa CDC now invites sealed Bids from eligible Bidders for Supply, delivery, installation and commissioning of various equipment, tools and items for the Douala Continental Logistics Base renovated warehouses. The tender is divided into 7 lots as follows:

- Lot 1: Storage and Safety equipment
- Lot 2: Vehicle and Material Handling Equipment
- Lot 3; Generators and other equipment
- Lot 4: Cold Chain Equipment
- Lot 5: IT and Electrical Equipment
- Lot 6: Office furniture
- Lot 7: Household Items

Each Lot is indivisible and bidders are allowed to bid for one or more Lots.

3. Bidding will be conducted through the Open Competitive Bidding (International), (OCBI) method as specified in the Bank's Procurement Framework dated October 2015, and is open to all eligible bidders as defined in the Procurement Framework.
