The Africa Union has received financing from the World Bank toward the cost of the Africa Centres for Disease Control Support Program to Combat Current and Future Public Health Threats Project (P178633) and intends to apply part of the proceeds toward payments under the contract¹ for Supply and Delivery of Vehicles for Africa CDC.
- 2. The African Centres for Disease Control and Prevision (Africa CDC) now invites sealed Bids from eligible Bidders for supply, delivery and installation of laboratory equipment in four lots, details provided in the bidding document, at Africa CDC, in Addis Ababa within 90 calendar days after contract signing date. Margin of preference is not applicable for this contract.
- 3. Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers July 2016 Revised September 2023 ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
- 4. Interested eligible Bidders may obtain further information from African CDC and inspect the bidding document during office hours from 8.00AM to 5.00PM from Monday to Friday at the address given below.
- 5. The bidding document in English may be requested by interested eligible Bidders upon the submission of a written application to the address below. The solicitation document will be sent by email upon request.
- 6. Bids must be delivered to the address below on or before 4 October 2024, 2:00pm Addis Ababa time. Electronic Bidding will be permitted and instruction for submission of bid
