Africa CDC Announces New Regional Leadership for Northern Africa and Key Appointments to its Governing Board

Africa CDC has announced a new chapter in regional public health leadership for Northern Africa, following the successful conclusion of the inaugural Northern Africa Regional Steering Committee (ReSCO) meeting held on 23 June 2025 in Cairo, Egypt.

By consensus, Member States appointed the Republic of Tunisia as Chair of the Northern Africa ReSCO and the People's Democratic Republic of Algeria as Vice Chair. In the same meeting, the Kingdom of Morocco and the State of Libya were

nominated to represent the region on the Africa CDC Governing Board, while the Arab Republic of Egypt was confirmed as the host of the Northern Africa Regional Coordination Centre (RCC).

The high-level meeting brought together Ministers of Health and heads of delegation from across Northern Africa, reaffirming a collective commitment to strengthen regional collaboration, formalize governance structures, and advance coordinated health security efforts.

Africa Unites to Take Stock of Disease Burden and Financial Needs towards NTDs Elimination by 2030

Fifty African Union Member States have endorsed a new digital micro-planning platform developed by Africa CDC to accelerate the elimination of Neglected Tropical Diseases (NTDs) by 2030. The tool, launched during a high-level workshop in June, enables countries to align national NTD strategies, improve coordination, track resources, and mobilize sustainable financing—especially critical amid declining global support. Country-specific plans for the six most common NTDs have already been submitted, marking a major milestone in Africa's collective health agenda.

NTDs affect over 565 million people across the continent and remain a major driver of disability, stigma, and poverty. With support from WHO, the END Fund, and partners, the initiative promotes African-led, data-driven planning to maximize efficiency and impact. Africa CDC has reaffirmed its commitment to work alongside Member States to close resource gaps, enhance local ownership, and ensure no community is left behind in the fight against these often overlooked but devastating diseases.

Africa CDC Champions Africa-Led Solutions at Africa Health ExCon 2025

As co-organiser of Africa Health ExCon 2025 held in Cairo, Egypt, Africa CDC played a central role in shaping dialogue around the continent's health future. During the opening ceremony, Acting Deputy Director-General Dr. Raji Tajudeen urged stakeholders to align investment and innovation with African priorities, calling for the next decade to be declared the "Decade of Health Sovereignty" under Agenda 2063.

Throughout the event, Africa CDC highlighted key pillars for progress including responsible use of Al for health, domestic manufacturing of medical products, strengthened primary healthcare, empowered community health workers, and sustainable domestic financing.

Africa CDC also hosted a high-traffic exhibition booth, which welcomed key dignitaries including Namibia's Minister of Health and Social Services, Dr. Esperance Luvindao. The visit provided an opportunity to discuss ongoing collaboration and strategies to support resilient health systems across the continent. The agency used the platform to reaffirm its commitment to Africa-led innovations, cross-country partnerships, and health equity for all.


